## Topic

Data Collection Status – ROSS Data Update

- Continuing to incorporate data from 2012 to present. Information will be integrated into a variety of pivot charts and tables for committee review.
- Topic added to November agenda.

Recognition of Prior Learning (RPL)

- The DOI Office of Emergency Management RPL can serve as a model to help create a formal qualification process through historical recognition for wildland fire.
- Points for consideration:
  - o Appeal process (Kirsten to report back on DOI's process in November).
  - o Core competencies vs. incident need What is the approach at the unit level?
  - o Set parameters on areas of focus.
- Texas is one of a few states with a current RPL process.
- The NE Forest Fire Compact tried to implement, but without a national standard process for implementation, they needed to re-invent and the effort stalled. Managing a successful Review Board is a lot of work.
- Jim Prevette will inquire as to which states currently have RPL systems in place and report back at November meeting.
- Agreement that RPL may not be appropriate for all functional areas or all positions.
- IPSC is the appropriate forum for addressing RPL. Celino and Bender will draft a memo to IPSC requesting they investigate a national standard for RPL
- Topic added to November agenda.

Status of Agency Roles/Leadership White Paper

- Slight modifications were made to the paper to include a more defined problem statement, clarifying language, and placeholder charts to represent IMT data gathered from ICAP.
- Document will be presented at the combined NWCG/FMB meeting on October 16<sup>th</sup> to discuss whether the paper will assist them in talking to their agency executives.
